COUNT 1

On or about April 23, 2016, in the County of Santa Clara, State of California, the crime of MURDER, in violation of PENAL CODE SECTION 187, a Felony, was committed by HASIB BIN GOLAMRABBI AND OMAR GOLAMRABBI who did unlawfully and with malice aforethought, kill Golam Rabbi, a human being.

(CJIC-SPC, JRS-QN) It is further alleged that the defendant, HASIB BIN GOLAMRABBI, has in this proceeding been convicted of more than one offense of murder in the first and second degree, within the meaning of Penal Code section 190.2(a)(3).

(CJIC-AAFA, JRS-VW) It is further alleged that in the commission of a felony specified in subdivision (a), and charged above, the defendant, HASIB BIN GOLAMRABBI, personally and intentionally discharged a firearm, a(n) handgun, and proximately caused, the death of Golam Rabbi, a person other than an accomplice within the meaning of Penal Code sections 12022.53(d) [and 12022.53(c) and 12022.53(b)].

(CJIC-OTH) It is further alleged, within the meaning of Welfare and Institutions Code section 707(d)(2)(A) that the defendant, OMAR GOLAMRABBI, was a minor, 14 years of age and older, specifically, 17 years of age, (DOB: August 4, 1998), at the time of the commission of the offense of murder with special circumstances, which if committed by an adult is an offense punishable by death or life in prison.

(CJIC-SPC, JRS-QN) It is further alleged that the defendant, OMAR GOLAMRABBI, has in this proceeding been convicted of more than one offense of murder in the first and second degree, within the meaning of Penal Code section 190.2(a)(3).

COUNT 2

On or about April 23, 2016, in the County of Santa Clara, State of California, the crime of MURDER, in violation of PENAL CODE SECTION 187, a Felony, was committed by HASIB BIN GOLAMRABBI AND OMAR GOLAMRABBI who did unlawfully and with malice aforethought, kill Shamima Rabbi, a human being.

(CJIC-SPC, JRS-QN) It is further alleged that the defendant, HASIB BIN GOLAMRABBI, has in this proceeding been convicted of more than one offense of murder in the first and second degree, within the meaning of Penal Code section 190.2(a)(3).

(CJIC-OTH) It is further alleged, within the meaning of Welfare and Institutions Code section 707(d)(2)(A) that the defendant, OMAR GOLAMRABBI, was a minor, 14 years of age and older, specifically, 17 years of age, (DOB: August 4, 1998), at the time of the commission of the offense of murder with special circumstances, which if committed by an adult is an offense punishable by death or life in prison.

(CJIC-SPC, JRS-QN) It is further alleged that the defendant, OMAR GOLAMRABBI, has in this proceeding been convicted of more than one offense of murder in the first and second degree, within the meaning of Penal Code section 190.2(a)(3).

On the morning of Saturday, April 23, 2016 the crime of homicide occurred within the City of San Jose, County of Santa Clara on the 3000 block of Lucas Court. On Sunday, April 24, 2016, at approximately 1347 hours, San Jose Police Department Communications received a 911 call advising that relatives of the victims from the Lucas Court address had walked inside and observed writing on the floor and walls then discovered the first deceased victim inside a room in the house. San Jose Police Officers arrived on scene and discovered the two victims inside.

The victims, Golam Rabbi (11/27/1956) and his wife Shamima Rabbi (12/31/1958) sustained multiple gunshot wounds and were pronounced dead at the scene by San Jose Police Personnel at 1600 hours.

The victims shared their house with their two sons, Omar Golamrabbi (age 17) and Hasib Golamrabbi (age 22), who were not at home at the time their bodies were discovered. Relatives had called and spoke to Omar and Hasib at about 0930 hours on Sunday, April 24, 2106, and the brothers advised that they were in Oakland for a convention. The relatives requested they return home as the victims were not responding to their phone calls, knocks on the door to the home and Golam missing work.

The relatives waited for several hours, but when the brothers failed to show up and stopped answering their phones they went to the victims' house where they discovered the victims' bodies. Omar eventually called a family member while police were already at the house and was subsequently located by officers about 2 miles from

his house. Hasib had not made any attempt to contact his relatives or the police and he turned his cell phone off.

I later interviewed Omar at the San Jose Police Department. Omar stated that he and his brother Hasib had left their house at about 0930 hours on Saturday morning, April 23, 2016, for an anime convention at the Oakland Convention Center. He stated his mother was still sleeping in bed, but his father was up when they left the house. He and his brother spent the night at a hotel in Oakland and began driving back Sunday morning after receiving calls from his relatives. His brother let him out of the car about 2 miles from their house and drove away. Omar was about to walk home when an officer located him.

On Tuesday, April 26, 2016 investigators reviewed the multiple sets of writing that had been found on the walls in the family home where the bodies were discovered. The writing could be grouped into that by two different authors. Investigators compared them to writings from notebooks found in Omar and Hasib's bedrooms and observed one group had specific writing characteristics consistent with Omar's writing.

Hasib and Omar were arrested on April 27, 2016 and interviewed. Hasib revealed in a recorded, Mirandized statement that he shot his father multiple times inside the garage because a stranger whom he could not name had assaulted him in the home had told him to do that. When asked about his mother he explained that he did not see her shot adding it was another person.

Omar, in a recorded, Mirandized interview stated that he was present in the home when his brother Hasib committed both murders. Omar did not mention the presence of a stranger or any other person. Omar stated that at his brother's request, he closed the

curtains after Hasib had killed their father. Then Hasib killed their mother. Omar stated that at his brother's request he checked the closed garage door before the two drove away from the home to make sure that blood was not seeping out from inside the garage where his father had been killed to outside the house. He got out of the car, checked that no blood was seeping out of the garage, and got back into the car with his brother. Omar stated that then he and Hasib left to go to a convention in Oakland, where they were seen to have been behaving normally.

While at the convention in Oakland, neither brother contacted the police, called or asked anyone for help, or told of the killings of their parents. After Omar was dropped off by Hasib on Sunday, April 24, he did not admit to any involvement or knowledge of the killings of his parents and continued to state that he had no knowledge of the killings until after being arrested on April 27, 2016. Hasib did not respond to multiple attempts to contact him by the police until arrested on April 27, 2016.

Based on the totality of the circumstances, I believe Hasib Golamrabbi and his brother Omar Golamrabbi murdered victims Golam Rabbi and Shamima Rabbi.
